## 1. Welcome and Apologies

Sandy gave a particular welcome to new Committee members, and our new Coordinator, Molly Jureidini.

- 2. Minutes of previous meetings (Nov. 6, 2018) were accepted by consensus.
- 3. Minutes of the AGM 20<sup>th</sup> Nov. 2018 (to be formally adopted at the next AGM) It was agreed that the minutes be accepted, with the following amendment made on page 3, immediately before item 5:

As there were less than 10 nominees, and as there were no objections to the nominees, all nine nominees were declared duly elected.

And that Mij Tanith's surname be added.

# 4. Future Agendas

It was agreed that we will use a Consent Agenda, whereby there may be lots of information on the agenda that does not need to be talked about, unless someone has questions to raise. One of the first items on the agenda will be an overview of the agenda for discussion

#### 5. Business

## 6. Ongoing Projects

### • Interview Project Stories

The documents are in the J4RSA office. Any use of material will require permission of the interviewees, and di-identification of individuals. We need to use them on our website, in social media the Federal election campaign and in the PowerPoint presentation. This will counter the Government's dehumanization of refugees.

It would help if we use RCOA's slide show (for consistency of message), adapted for our purposes and with our stories.

ACTION: Molly and Kirsty will read the stories to see what could be used, and Meredith will meet with them in January to consider the next actions.

## • Harmony Day Planning – March 13th

This is about recognizing the value of diversity; lots of schools participate. ACTION: Molly will check out the Harmony Day website to see what others are doing.

Agreed not to do anything on our own, given limited resources.

#### Recruitment of Interns

We need to check the guidelines and ask what J4RSA gains from them.

ACTION: Molly will look at the information Ruth left in early January and inform MC members.

ACTION: Gary to put this on the January agenda.

Sandy wondered if Masters of Social Work students could be of benefit to J4RSA in 2019, possibly looking at the use of those stories.

ACTION: Sandy will follow up.

## 7. Finance Reports

Molly had circulated November and YTD reports, based on what Max Beacom (former Treasurer) and Afsoon had done, prior to the meeting. Figures are filed with the minutes.

There may have been a loss in October, but a profit in November of \$2,300.

ACTION: Afsoon will check in QuickBooks, and also create more categories of expenditure so they are easier to track.

The sort of information MC wants is:

- O How are we travelling in comparison to the budget?
- o How many donations have come in from July to Dec. 30?
- o What are our membership numbers compared to this time last year?

ACTION: Afsoon will bring a copy of the 2018-19 budget to the next meeting.

ACTION: Darryl and Molly will work on a January to June 2019 budget based on a workplan, with Meredith and Gary to be called in if needed.

Molly has the skills to update information, create a hub, and put in links to resources.

ACTION: Molly will liaise with Marie Wood and the person who was doing the update.

Purchases by Coordinator

Molly was authorized to have \$100 petty case for work-related purchases, and to keep receipts.

ACTION: Executive will investigate getting a debit card.

Setting up and bumping out of ALP Conference

ACTION: Chris Keating will help Gary on Saturday afternoon and Meredith will help on Tuesday afternoon.

Registration for the ALP Conference

Stall holders do not need passes, but J4RSA can register 2 observers who can get passes into the convention. Chris Keating and Sandy Boyce will already be attending.
